Payment of Management Fees by way of Units in Fraser's Commercial Trust

Singapore, 22 January 2020 – Fraser's Commercial Asset Management Ltd. (the "**Company**"), as the manager of Fraser's Commercial Trust ("**FCOT**"), announces that the Company has on 22 January 2020 received 1,725,887 units in FCOT ("**Units**") issued at a price of S\$1.6441 per Unit (the "**Issue Price**") in payment of the base fee component of the management fees for the period from 1 October 2019 to 31 December 2019 ("**Management Fees**"). The amount received in Units constitute 100% of the Management Fees.

As a result of the above issue of Units, the Manager's interest in the 916,622,020 total Units in issue as at 22 January 2020 is as follows:
