Frasers Property Limited ("FPL") holds a 100% direct interest in each of FCOAM and Frasers Property Commercial Trust Holdings Pte. Ltd. (formerly known as FCL Trust Holdings (Commercial) Pte. Ltd.) ("FPCTH"). FCOAM and FPCTH hold FCOT Units, and FCOAM is deemed interested in FCOT Units which are held directly by its wholly-owned subsidiary, Frasers Centrepont Property Management (Commercial) Pte. Ltd ("FCPMC"). FPL therefore has a deemed interest in the FCOT Units in which each of FCOAM and FPCTH has an interest, by virtue of Section 4 of the Securities and Futures Act (Chapter 289) of Singapore ("SFA").

IBIL holds a greater than 20% interest in FPL;
 – FPL holds a 100% direct interest in each of FCOAM and FPCTH;
 – FCOAM holds a 100% direct interest in FCPMC; and
 – FCOAM, FPCTH and FCPMC hold FCOT Units.

IBIL therefore has a deemed interest in the FCOT Units in which FPL has an interest, by virtue of Section 4 of the SFA.
