("FPCTH"). FCOAM and FPCTH hold FCOT Units, and FCOAM is deemed interested in FCOT Units which are held directly by its wholly-owned subsidiary, Frasers Centrepoint Property Management (Commercial) Pte. Ltd ("FCPMC"). FPL therefore has a deemed interest in the FCOT Units in which each of FCOAM and FPCTH has an interest, by virtue of Section 4 of the Securities and Futures Act (Chapter 289) of Singapore ("SFA").

TCC Assets Limited ("TCCA") holds a majority interest in FPL;

- FPL holds a 100% direct interest in each of FCOAM and FPCTH;
- FCOAM holds a 100% direct interest in FCPMC; and
- FCOAM, FPCTH and FCPMC hold FCOT Units.

TCCA therefore has a deemed interest in the FCOT Units in which FPL has an interest, by virtue of Section 4 of the SFA.
